



## Personal Short Term Car Leasing & Short Term Van Leasing 6 months+

**Athol Car Hire** has a product called **6 MONTHS+** that bridges the gap between conventional Car and Van Rental and long term Leasing or Contract Hire.

Starting from just £220 + vat per month, this product is particularly suitable to Employers taking on new or temporary Staff or perhaps for a New Employee requiring temporary transport to/from work whilst they decide what vehicle to purchase, perhaps waiting to complete their work probation period before making the decision to outright purchase or maybe whilst they await delivery of a new vehicle. The main advantage of this product is that it provides a hassle free solution to your short term motoring needs which includes everything in the price except the fuel.

### What is the minimum duration for Short Term Car or Van Leasing?

The minimum period is 6 months.

### What is the maximum duration for Short Term Car or Van Leasing?

You can continue to extend the hire duration beyond the initial period up to a maximum period of 3 years but if you know from the outset that you require a vehicle longer than 18 months, then it may be more cost effective for you to consider **Contract Hire** packages from us.

### What vehicle can I have on a Short Terms Leasing Contract?

We supply Nissan vehicles which are all currently registered and being used on a day to day basis from our own rental fleet. All vehicles supplied are 1-18 months old.

### What's included in the rates?

1. **Fully Comprehensive Insurance Cover** with a "Damage Responsibility Excess" of £500 per incident
2. **Up to two nominated & approved drivers** aged 23 years and over who hold a full current driving license min 12 months and unendorsed other than for minor offences (eg: speeding x2)
3. **An annual mileage allowance of 10,000 miles** with excess miles charged at £0.05p per mile + vat. (5,000 miles for 6months, 7,500 miles for 9 months, etc)
4. **Vehicle maintenance & 2 replacement tyres** (from normal wear & tear)
5. **Annual Road fund license fee**
6. **A replacement vehicle** in the event of vehicle being off road
7. **VAT @ 20%**

### What's excluded from the rates?

1. **a Damage Responsibility Excess** of up to a maximum of £500 per incident, covering any damage to the vehicle including tyres, wheels, trims, mirrors, radio aerial, the roof, underside, interior (eg: Cigarette burns, dog hairs etc) incorrect refuelling & loss to keys
2. **Isle of Man use only.** Vehicles must remain in the Isle of Man unless otherwise authorised in writing.

### How do the payments work?

A payment of 3 monthly payments in advance followed by single monthly payments made thereafter in advance to the end of the chosen contract period. I.e.: 6 months = 3+5 monthly payments, 9 months = 3+8 monthly payments, 12 months= 3+11 monthly payments etc..

### Availability

Normally within 24 hours.

If we don't have your preferred vehicle available, then we may look to supply an alternative upgrade vehicle for a few days to keep you mobile until one becomes available.
